Regulations for the Implementation of the Xin Miao Advanced Technology Doctoral Scholarship

Article 1 The Xin Miao Education Foundation ("Xin Miao Foundation"), a non-profit organization, has established the "Xin Miao Advanced Technology Doctoral Scholarship" to encourage outstanding doctoral students to study at National Taiwan University ("the university"). The regulations are stipulated by the university according to the contract between both parties.

Article 2 Eligible Recipients and Qualifications:

Local students admitted to the doctoral program through the annual selection process or admission process of the doctoral program of the university, whose department, graduate institute, or degree program (hereinafter "departments") are in the fields of sustainable development, electrical engineering, information engineering, communication engineering, artificial intelligence or biomedical engineering. However, those who have been admitted but have not completed the registration for the current academic year are not eligible to receive this scholarship.

Article 3 Method and Quota of Awards:

Five students each year; monthly disbursement after enrollment, with each recipient receiving a monthly stipend of NT\$30,000; the student can receive the scholarship for up to three academic years.

Article 4 Composition of the Scholarship Review Committee:

Comprised of one representative appointed by each college, and the representatives mutually recommend one person to serve as the chairperson.

Article 5 Application and Review Procedures:

New students submit their applications to their colleges within the announced time frame by the Office of Academic Affairs. Each college selects candidates according to these regulations and submits a

recommended list to the Scholarship Review Committee. The recommended list is reviewed by the interdisciplinary scholarship review committee, and the award recipients are selected. The list of awardees is then communicated to the Xin miao Foundation by the university.

- Article 6 Starting from the second semester after enrollment, scholarship recipients must be recommended by their advisor to continue receiving the scholarship. The scholarship will be canceled for recipients who meet any of the following conditions, and it will not be reinstated:
 - 1. Taking a leave of absence, transferring to another department, withdrawing from the university, or engaging in full-time employment at a public or private institution. The scholarship will be suspended starting from the following month after the occurrence of the event.
 - 2. If it is verified that the scholarship recipient has forged, altered, or provided false information, the scholarship will be suspended starting from the following month after the occurrence of the event, and the received scholarship funds must be repaid.

After the scholarship eligibility is revoked for any reason, the vacant award quota may be filled by eligible candidates from the same academic year in order of priority.

- Article 7 Recipients of this scholarship are not eligible to concurrently receive the following grants or subsidies:
 - 1. The University's Higher Education SPROUT Project—Research Promotion Program for Direct-Entry Doctoral Degree Program Students.
 - 2. Doctoral Student Scholarship provided by the university.
- Article 8 The Xin Miao Foundation may request scholarship recipients to provide relevant information regarding their personal learning experiences and insights (including name and photos) for inclusion in their annual reports and website as public content.
- Article 9 The Regulations shall be agreed upon by the Xin Miao Foundation and passed by the Administrative Meeting and then implemented on the date of promulgation.
