Directives Governing the Implementation of Fu Bell Scholarship

May 14, 2019 Discussed and passed by the 3,041st Administrative Meeting February 18, 2020 Amended and passed by the 3,062nd Administrative Meeting

- Article 1 The *National Taiwan University* ("the University") *Directives Governing the Implementation of Fu Bell Scholarship* ("the Directives") are formulated to encourage exceptional high school graduates to pursue undergraduate studies at the University.
- Article 2 Scholarship targets: Prospective domestic undergraduate students who are enrolling at the University and hold any of the following qualifications:
 - 1. Outstanding college entrance examination grades
 - 2. Awards at major international competitions
 - 3. Other exceptional achievements

Article 3 Scholarship quota:

- 1. Collegiate quota: The number of recipients per college shall be calculated based on the number of departments. In principle, one quota place shall be available per department. The quota places may be transferred between departments of the same college. The college shall be responsible for approving students to receive the Fu Bell Scholarship ("the Scholarship").
- 2. **Intercollegiate quota:** 10 quota places in total may be awarded the Scholarship at the recommendation of their respective college and with the approval of the Scholarship Review Committee.
- 3. Additional collegiate quota: In principle, a total of 15 additional quota places may be awarded the Scholarship at the recommendation of their respective college and with the approval of the Scholarship Review Committee. The University and students' respective college shall each provide half of the stipulated amount.
- Article 4 Freshmen who are approved for the Scholarship may each receive up to NT\$ 800,000 in accordance with the following payment method:
 - 1. A payment of NT\$ 100,000 shall be issued in the first semester after admission.
 - 2. From the spring semester of the freshman year until graduation (excluding extension of study), recipients will receive NT\$ 100,000 per semester (for up to eight semesters) provided that they are enrolled, that their academic performance in departmental (divisional) required subjects in the previous semester ranked in the top 10% of the same year of study (rounded to the nearest integer), and that they meet the minimum credit requirements. (Recipients approved to pursue overseas studies shall take at least two subjects or six credit hours per semester abroad.)
- Article 5 Applicants for the Scholarship shall prepare the necessary documents and submit an application within the application period stipulated by their respective department or college. Following a review by the department and college, the latter shall approve or recommend recipients based on its quota.

Recommendation forms and the relevant documents shall be submitted to the Scholarship Review Committee appointed by the Office of Academic Affairs for approval.

- Article 6 An executive vice president of the University shall serve as convener of the Scholarship Review Committee, whose members shall consist of the Vice President for Academic Affairs and the dean of each college or a committee member appointed by the dean.
- Article 7 Recipients who fail to register or apply for retention of admission status or leave of absence in the first semester following admission shall have their Scholarship revoked.
- Article 8 For recipients applying for change of major, whether or not they may retain their Scholarship shall be determined by the Scholarship Review Committee.
- Article 9 Recipients of the Scholarship may not concurrently be recipients of the University's Voyage of Aspirations Scholarship, Hope Scholarship, or Hope Financial Aid.
- Article 10 Funding for the Scholarship shall be supported by the University's Endowment Fund or other budgeted funding sources.
- Article 11 Recipients found to have falsified or tampered with documents shall have their Scholarship revoked and shall return the total amount of the payments already received. They shall be held accountable based on actual circumstances.
- Article 12 The Directives shall be passed by the Administrative Meeting and then implemented on the date of promulgation.
